ETHICS POLICY

Our business efforts are forged with an eye toward the future and are grounded in the principles of running an accountable and responsible corporation. To help us fulfill our responsibility, El Kekhia Group has taken additional steps in establishing worldwide methods for employees and suppliers to report any matters they believe may not be in line with Company values or legally acceptable standards. El Kekhia Group has established the Kekhia Business Ethics Committee ("Ethics Committee"), which is responsible for overseeing all internal investigations regarding matters involving business ethics, and ensuring compliance with legal and internal requirements relative to matters of business ethics. The Ethics Committee is available to anyone inside or outside of the company who wishes to make a report.

Please be aware the Ethics Committee will handle all reported matters in a confidential manner and will endeavor to preserve anonymity, if desired, in a manner consistent with the best interests of the parties involved and legal requirements.
